

[Genesis] In realizing we are not alone in the Universe, I accepted the probability that numerous constellations were teeming with humanoid life. More importantly, as I will demonstrate from the written record, I discovered a chain of command governing at least twelve of these inhabited constellations.

This cosmic leader or superior being is characteristically distinguished as Yahweh. (Elohim, YHVH, Yahveh, El, Adonai). Moreover, this extraordinary physical entity maintains authority over numerous inhabited worlds, as well as diverse craft, devices, machines, weapons and instruments of destruction at his command.

This phenomenal technology actually assisted me in resolving many of the believed miracles found within Scripture, including “**the Creation**” thesis. Over considerable time, my research ultimately revealed that the scriptural creation premise did not consist of the palpable construction of this Universe or its planetary constellations. Nor did the scriptural chronicles of the creation entail the construction of a single planet, including “Earth”.

UFO Connection

Through my UFO research it became clear that if the reader was to comprehend the extraterrestrial implications of scripture and its creation thesis, I had no other choice but to disclose an astonishing device shrouded within the UFO enigma. Probing the nature of UFOs, I discovered that the occupants of these mysterious craft have been consistently utilizing an extraordinary technological device. The application of this device has been witnessed time and time again in numerous UFO encounters, as well as exploited upon many individuals abducted by UFOs. Yet, more significantly, this miraculous device may in fact be the fundamental clue in resolving the creation theory found in Genesis.

Doing the research it became clear that these elusive entities have technologically mastered the physical manipulation of solid matter. Essentially, it would appear that these visitant beings have designed and fabricated a device fully capable of maneuvering solid objects from great distances without actual contact with the object.

The use of this unique device has been reported in numerous UFO abduction cases where individuals were bodily elevated by UFOs utilizing levitating beams of energy. Even the occupants of these prodigious craft have been observed as they were bodily elevated or lowered from a hovering craft with no strings attached.

November 17, 1967 Alberta, Canada -- A thirteen-year-old boy walking home from a friend's house encountered a silvery-grayish glowing object as big as a house. As the frightened boy began to run, he was bodily seized and elevated into the craft by an orange shaft/beam of light emanating from its lower mid-section. November 10, 1969 Quincy, Il. -- An X-ray technician, along with his wife and son, were driving on State Highway 96 about 13 miles south of Quincy. Suddenly a red glowing object moved directly over their car. It raised the vehicle about a foot up off the paved highway. Published in, Sky Look, January 1970, May 1971/UFO Report March 1977

September 2 1971 Tombos, Rio de Janeiro, Brazil -- A man stopped his car to observe a

UFO as it established a stationary position in front of him. Suddenly two bright beams of light shot from the craft, striking the car and forcing the door of the vehicle open. The two light beams began roaming the side of the car and focused on the driver's seat where they began pushing the man, forcing him from the car.

In desperation the terrified man grabbed the steering wheel, only to find that the beams of light began dragging him out of the car by his legs. Clawing at the ground, grabbing rocks and bushes, the man was extracted from the car and bodily floated into the awaiting craft where he was confronted by three gray beings in "jump suits". The last thing he remembered was the whine of a turbine as he opened his eyes and saw his car a few feet away. Published in Official UFO, Collector's Edition 1976

October 17, 1973 -- A man reported that while driving his pickup truck, he exited the Loxley, Alabama, off ramp on interstate 10, where he was suddenly confronted by a huge UFO hovering directly over his truck. The massive object unexpectedly projected a beam of light down onto the truck, at which point the vehicle began rising up off of the paved road and was elevated into the craft where the driver was met by six strange-looking creatures.

The terrified witness remained in the craft for approximately thirty minutes while he was studied by the occupants. The Florida electrician and his truck were released unharmed on State Road 297, 50 miles east of Pensacola, 85 miles from where the bizarre abduction began. Published in, UFO Report, March 1977

February 25, 1999 Washington State -- Three forestry workers planting seedling trees in the mountains witnessed a small, disc-shaped object traveling south as it entered into a valley to their north. The disc-shaped UFO appeared to wobble as it descended towards a herd of elk that the forest workers had been watching all morning.

Suddenly the Craft quickly positioned itself over one of the separated adult animals. The lone elk was lifted up off the ground by the disc-shaped craft. Although no visible method of support was observed, the forest workers claim the object began elevating the elk up to the disc-shaped object while ascending and accelerating up a clear-cut slope to the east.

The craft wobbled as it brushed tree tops and executed a 360-degree turn. It quickly ascended at a steep angle and disappeared from sight. Courtesy of National UFO Reporting Center (NUFORC) Peter B. Davenport, Director.

August 6 2002 Northumberland Pennsylvania -- A Farmer reported a round object hovering near power lines on top of Montour Ridge. The object was observed moving a few hundred feet east, where it stopped and projected a beam of blue and white light to the ground.

The farmer claimed he saw a man suspended within the beam of light being pulled up head first into the hovering craft. The craft shuddered for a moment before quickly moving west and abruptly stopping prior to ascending straight up and disappearing. These evasive entities have devised a way to surgically manipulate solid matter without physical contact. They appear to possess artificial matter maneuvering devices harnessing the power to aerially levitate cars, trucks or even the human body. In fact, it would appear that these mysterious craft are fully capable of elevating and mobilizing a multitude of various objects to

any given site while hanging in midair.

Quite naturally, super technology would dictate super structures, craft, weapons, and devices, indicating that these matter transporters could be as small as a hand-held device, or as large as a football stadium mounted on a mother ship.

The Creation and Matter Manipulation

The essential question would be how do UFOs and their matter maneuvering devices fit into the scripturally accepted creation of this planet? This perplexing issue ultimately revealed that the planet Earth, and this entire Universe, existed **before** the creation actually took place.

3. There I saw the wooden receptacles out of which the winds became separated, the receptacle of hail, the receptacle of snow, the receptacle of the cloud, and the cloud itself, which continued over the earth before the creation of the world.

CHAP. XLI.

BOOK OF ENOCH

How could the clouds, rain, hail and snow, existed “over” the Earth “before the creation of the world? Obviously, the planet Earth already existed, the creation was nothing more than a major modification, or face lift performed upon a pre-existing world.

1:1 In the beginning God created the heaven and the earth.

1:2 And the earth was without form, and void; and darkness [was] upon the face of the deep...

GENESIS

Naturally, the verses would entice one to believe that the planet Earth was created out of thin air. This assumption becomes even more credible when considering the version that God (Yahweh) created “Heaven” and “Earth”. The word “Earth” is believed to be a direct reference to the planet Earth itself. In contrast, the word “Heaven” is considered to be a reference to the Universe, and/or an invisible realm.

However, the verses do not state that Yahweh/God created the waters of the deep. The waters (“the deep”) already existed, indicating that the pre-existing waters/deep, were already on the pre-existing world.

EARTH - *The land surface of the world. The softer, friable part of land; Soil, especially productive soil. Soil or dry land, ground, dirt.*

HEAVEN - *The sky, the firmament*

FIRMAMENT - *The sky*

Instinctively, we believe the earth to be the planet, and heaven to be an invisible realm or outer space beyond this world (the Universe). Yet, both words possess other definitions establishing an unprecedented narrative. The word ‘heaven’ defines the sky or firmament of this planet. The sky being the firmament is actually the atmosphere or mass of air that encompasses this world. In essence, Yahweh created/alterd this planet’s atmosphere (sky/firmament/heaven), not the Universe. The word “Earth” implies land or dry ground, dirt. Hence, Yahweh created the dry land (“Earth”) upon a pre-existing planet comprised of water, a conjecture that is actually validated by the verses of Genesis.

1:8 And God called the firmament Heaven. • • •

1:10 And God called the dry [land] Earth; and the gathering together of the waters called he Seas: and God saw that [it was] good.

GENESIS

Essentially, Yahweh created the sky or atmosphere (heaven) as well as “dry land/Earth” (continents), upon a pre-existing **aquatic** world. Yet, how could Yahweh and his universal forces perform such an incredible planetary feat? This astonishing world altering maneuver began to disclose its genuine design by revealing the fact that the existing dry land “Earth” was without form and void.

FORM - *The shape and structure of an object. The body or outward appearance, The mode in which a*

thing exists, shape.

VOID - Not occupied; Unfilled. Completely lacking; Devoid. Ineffective; Useless. null.

Obviously, insignificant land or dry ground (earth) existed upon the unaltered world. Yet, the diminutive land bodies displayed no basic “form” or defined shape, possibly indicating negligible land masses and enormous marshlands. The land was “void” suggesting that the insignificant unformed land masses, or marshlands (earth) that did exist at that time, were not occupied by many land dwelling life forms due to the planet’s aquatic nature.

If in fact there were insignificant dry land bodies and massive marshlands then quite naturally the planet was an aquatic world consisting of mostly water “**The Deep**”. It was this aquatic element that actually assisted me in resolving the issue as to how the creation was actually performed.

Gather Together the Waters

Surprisingly, the verses held nothing back in disclosing the global mutation. Yahweh and his host forcibly altered or manipulated the former seas and oceans (The Deep) of this planet, thus spawning the conversion of a pre-existing aquatic world. Verse 1:10 confirms that the waters of the planet were physically altered “**gathered together**” or forcibly refashioned.

4 He also divided the earth from the water, with which it is encompassed;... I. CLEMENT

28 ... and with the word of his strength fixed the heaven, and founded the earth upon the waters;... I.

THE LOST BOOKS OF THE BIBLE

6. Is not the whole sea, all its waters, and all its commotion, the work of him, the Most High; of him who has sealed up all its exertions, and girded it on every side with sand? CHAP. C. BOOK OF ENOCH

The massive oceans (“waters”) of this planet played a major role in the transmutation of this previous aquatic world. Moreover, it would appear that this global conversion also created the prevailing sunlight that now exists upon the surface of this world today. That daylight surged into existence due to the forced mutation of the previous atmosphere/ heaven/firmament/sky).

1:3 And God said, Let there be light: and there was light.

1:4 And God saw the light, that [it was] good: and God divided the light from the darkness.

GENESIS

How could these celestial entities have forcibly extracted, “**gathered together**” and stabilized a global body of water, and still maintained this planet’s perfect perpetual balance? How was dry land/earth forced to appear on the surface of the planet were there was none before? How was the previous atmosphere altered (heaven) thus allowing the Sun (light) to radiate upon the newly exposed dry land?

Moon Alters Heaven and Earth

27. During the period of its fury he has established the sand against it, which continued unchanged for ever; and by this oath the abyss has been made strong; nor is it removable from its station for ever and ever. CHAP. LXVIII

BOOK OF ENOCH

27 ... And thus I made the solid waters, that is to say, the bottomless. And I made a foundation of light around the water.

28...The sea I gathered into one place, and I bound it with a yoke. And I said to the sea: Behold, I give you an eternal boundary. And you will not break through from your own waters. And so I fixed the solid structure and established it above the waters. ...

30 ... and on the 7th, the lowest, [I placed] the MOON, and with the lowest stars I beautified the air below.

2. I surveyed the stone which supports the corners of the earth.

3. I also beheld the four winds, which bear up the earth, and the firmament of heaven.

The mutation of this world was performed by the orbital installation of a Moon (“stone”) around the planet. The evidence and obvious logic are overwhelming. The “yoke” or “solid

structure” (Moon), established above the waters of this World, is the “stone” (Moon) that supports the creation (corners of the **earth/dry land**).

Remarkably, a simple encyclopedia validates the premise. Our scientists know that the gravitational pull of the Sun and Moon creates a massive aquatic bulge on the surface of the planet. This aquatic protrusion is in fact the waters of the planet that have been “**gathered together**” and are being pulled away from the surface of the planet. In essence, the lunar induced protrusion helps to keep the continents of the planet dry.

We need only to examine the premise in reverse to expose the facts. One would only need to reflect upon the detrimental impacts of our Moon being removed from its present orbit around this world. Those devastating repercussions would alter this entire planet back to its pre-existing aquatic state, being extremely deficient of dry land.

Evidently, this former aquatic world possessed no physical Moon as we know it today. The planet Earth was simply an isolated water world embracing only small segments of formless land masses and possibly vast marshlands scattered throughout its surface. **If true**, this aquatic factor would imply that the previous atmosphere (heaven/firmament) of the planet would have also been dissimilar from our present atmosphere.

By there being more water exposed on the surface of the Planet, the Sun would be thoroughly capable of generating more water vapor into the planet’s atmosphere (**heaven/Firmament**). Consequently, there would be perpetual rainfall, as well as horrendous storms on a global scale. The planet in this aquatic condition would maintain a relentless cloud coverage engulfing its surface.

1:2 ... and **darkness** [was] upon the face of **the deep**. GENESIS

The rays of sun would be unable to penetrate the atmosphere of the Planet, due to the overwhelming cloud formations within the firmament (atmosphere/sky/heaven). There would be no light (daylight) as we know it today. The exposed small land masses and enormous marshlands that may have existed before the lunar alteration occurred would be tropical in nature, much like the tropical rain forest of Brazil. The plant and animal life forms that may have existed on the surface of the former world would have been quite extraordinary.

If these world altering entities physically lodged a Moon into orbit around this type of aquatic world, the global repercussions would be incredible. The gravitational pull of the newly installed Moon would “**gather together**” and extract the massive oceans and seas away from the submerged land masses, thus forming dry land (earth). The larger the installed Moon, the greater the pull would be. The closer the Moon is established around the Planet, the greater the aquatic extraction would be.

Science and religion began to mesh together. These celestial entities selected just the right size planetoid satellite (Moon), and physically positioned it into the proper orbit to produce the perfect aquatic extraction to create the biosphere christened **Earth (Dry Land)**.

By inaugurating a moon around the former aquatic world, they physically created or formed dry land masses (Earth/Continents), that did not exist before the lunar conversion was performed. Using the Moon to physically extract the oceans and seas away from the submerged land formations, they depleted the previous atmosphere of its perpetual water supply.

The lunar conversion had now left the aquatic planet with more solid land mass and reduced surface area of water, thereby globally reducing the area of water the Sun could physically evaporate into the atmosphere (Heaven/firmament). The aquatic reduction depleted the amount of rainfall as well as reducing the cloud coverage of the planet. The Sun’s rays could now penetrate the altered atmosphere and radiate the newly exposed dry land. Hence there was light.

1:6 And God said, Let there be a firmament in the midst of the waters, and let it divide the waters from the waters.

1:7 And God made the firmament, and divided the waters which [were] under the firmament from the waters which [were] above the firmament: and it was so.

1:8 And God called the firmament Heaven. And the evening and the morning were the second day.

1:9 And God said, Let the waters under the heaven be gathered together unto one place, and let the dry [land] appear: and it was so.

1:10 And God called the dry [land] Earth; and the gathering together of the waters called he Seas: and God saw that [it was] good.

GENESIS

Prior to the Lunar conversion, the “firmament” or highly humid atmosphere above (heaven/sky), was full of water vapor (rain), due to the Sun evaporating the enormous quantities of water covering the surface of the planet. Therefore, waters were **above**, within the firmament (atmosphere), as well as waters **below** the firmament, being the location of the massive oceans and seas.

The new lunar generated firmament would now insatiably divide and separate the waters of the atmosphere from the waters on the surface of the planet. Essentially, the conversion depleted the global cloud coverage due to reduced evaporation into the new atmosphere spawned by the lunar installation.

Jurassic Connection

There is more here than just the rationalization of a lunar conversion imposed upon an aquatic world. Our home world Earth has been around for millions of years **before** the lunar metamorphosis ever took place. Today our scientists know that millions of years ago this planet was in fact an aquatic world consisting of insignificant land mass, commonly known as “the age of fishes”.

It’s typically believed that the existing continents on the surface of this planet were formed by clashing plate tectonics, massive continental segmentation and/or volcanic magma oozing up from out of the planet’s crust via global fault lines. However, as we have just discovered, this planet evolving assumption may not be the entire truth. Nor would be the deemed hypothesis of the sudden disappearance of the dinosaurs.

Today the most common theory is that, millions of years ago, a large asteroid or meteor struck this planet, spawning global devastation. This cosmic collision was believed to have transformed this planet into a frigid dying World due to enormous amounts of expelled soot, ash, and increased volcanic activity ascending into its atmosphere. The doomed atmosphere became so darkened by the horrendous event that the sunlight was blotted out for years.

This dark event was believed to have caused the plant life on the surface of the Planet to die out, consequently exterminating the entire food chain, which eventually found its way to the rapid starvation, and ultimate demise of the dinosaurs.

However, we are now forced to face another possibility. The actual demise of the monstrous reptiles and their ecosystem may point an incriminating finger at the lunar conversion (creation) of this world. Moreover, this lunar perspective would reveal an astounding issue.

Extraterrestrial Intervention

Is it possible that this planet was physically claimed by extraterrestrial beings during the epoch in which it was inhabited by dinosaurs? Did they in fact remove or destroy the dinosaurs by way of the lunar conversion to establish accommodations for mankind?

The planet before the lunar transformation embraced only negligible land masses and vast marshlands. Due to the unaltered state of the atmosphere, the water-based planet at that time may have been extremely tropical in nature. The highly aquatic environment of the planet before the lunar conversion may have actually dictated an extraordinarily savage form of

evolution. Plant life would become aquatically bizarre, savage, and uncontrollable freaks of nature. The same savage nature would have ultimately evolved the aquatic and land-based animal life forms (Dinosaurs). This bizarre detail may not only explain the extinction of the dinosaurs, but the food chains that preserved their very existence.

Just like the theory of the asteroid or meteor that assaulted this planet decimating all plant and animal life, the lunar transmutation would yield similar effects. This lunar injection may have entailed devastating repercussions such as a possible pole shift capable of destroying every living thing on the surface of the former world.

Even if a catastrophic pole shift did not occur during the lunar conversion, by forcibly altering the planet, most of the plant and animal life forms would have been environmentally terminated due to lack of water.

The former cloudy and moisture laden atmosphere of the planet had been modified. The existing aquatic plant and animal life that were thriving under the previously cloudy atmosphere and abundant water supply would ultimately die out and/or be mutated. The water starved plants and animals, being saturated with the intense unfamiliar sunlight, would cease to exist, or transmogrify.

The food chain would be utterly altered, consequently transmuting or destroying all life forms in the wake of the lunar metamorphoses. Naturally, it would take many generations for the recently converted planet and its mutated life forms to become stabilized within their new environment, which may account for this verse.

2:4 These [are] the generations of the heavens and of the earth when they were created, in the day that the LORD God made the earth and the heavens, GENESIS

This timeless evolutionary balance is illustrated by the word “generations” suggesting that the “generations” spoken of in reference to the lunar creation may in fact delineate into millions of years.

A New World is Born

Then you commanded that a ray of light be brought forth from your treasures, so that your works might then appear.” Again, on the second day, you created the spirit of the firmament, and commanded him to divide and separate the waters, that one part might move upward and the other part remain beneath. “On the third day you commanded the waters to be gathered together in the seventh part of the earth; six parts you dried up and kept so that some of them might be planted and cultivated and be of service before you. ...

For immediately fruit came forth in endless abundance and of varied appeal to the taste; and flowers of inimitable color... 6:40-44 THE FOURTH BOOK OF EZRA (P)

1:11 And God said, Let the earth bring forth grass, the herb yielding seed, [and] the fruit tree yielding fruit after his kind, whose seed [is] in itself, upon the earth; and it was so.

1:12 And the earth brought forth grass, [and] herb yielding seed after his kind, and the tree yielding fruit, whose seed [was] in itself, after his kind; and God saw that [it was] good.

1:14 And God said, Let there be lights in the firmament of the heaven to divide the day from the night; and let them be for signs, and for seasons, and for days, and years:

1:15 And let them be for lights in the firmament of the heaven to give light upon the earth; and it was so.

1:25 And God made the beast of the earth after his kind, and cattle after their kind, and everything that creepeth upon the earth after his kind; and God saw that [it was] good. GENESIS

A new and different world would now replace the old. Mutated life forms would now begin to spontaneously develop, multifaceted life based on the converted planet and its now sun permeated environment. The pre-existing plant and animal life would either be aquatically starved, or unable to biologically adjust fast enough to compensate for the rapid environmental change.

The new biosphere would now possess vast quantities of naked or barren land masses due to the extracted waters spawned by the lunar injection. The self-seeding events spoken of in the verses would be a natural occurring condition on the surface of the void dry land masses (Earth)

if exposed to direct sunlight. The verses themselves express the self-procreating methods by stating “yielding seed after his kind, whose **seed is in itself upon the earth, after his kind**”.

Essentially, Yahweh allowed nature to follow its own procedure after the lunar transmutation. Moreover, many specific plant and animal life forms were able to survive by weathering the altered environment. This would not include the dissimilar types of plant and animal life that naturally sprung up due to the dissimilar order of environment now imposed upon the transfigured planet. The same metamorphosis would also occur in reference to the light and darkness, or days and nights now established on the created biosphere.

Prior to the earthly creation, there may have been no day or night on the surface of this world as we know it today. The planet maintained a perpetual darkness or overcast environment due to the horrendous cloud coverage engulfing its surface. The lunar generated biosphere altered the overcast environment thus creating light, as well as darkness, hence the literal creation of day and night.

The tides established by the lunar induction, in contrast with the gravitational pull of the Sun, are contributing factors that produce the current perpetual state of tilt and rotation that this planet maintains today. Essentially, the planet now generates an uninterrupted revolution that gives us our continuous twelve hour nights and days, which break down into weeks, months, years, or in essence time itself.

Matter Manipulation Connection

The ultimate question would be, just how was the lunar conversion physically performed? If the reader will recall, these mysterious entities have devised incredible matter manipulating devices. Moreover, this device is capable of maneuvering solid matter at extensive distances. Seemingly, these devices are mounted on/or within the craft themselves, thus allowing the craft the ability to aerially elevate abducted victims, or to bodily hoist and/or lower the occupants from their hovering craft.

As mentioned before, super technology would naturally dictate super structures, craft, devices, and weapons. If these celestial entities have in fact constructed super starships of enormous dimensions, they could in all probability possess the same matter maneuvering device of enormous size mounted on the immense craft. Essentially, these mountainous space-bound craft possess the ability to physically manipulate solid matter of untold masses. In all probability, these beings may be navigating gargantuan craft fully capable of planetary manipulation on a mammoth scale.

These stellar beings may be quite proficient in not only locating a planetoid satellite (Moon) of their own choosing, but transporting the selected planetoid within the weightlessness of space. In fact, this astonishing satellite maneuver may be quite simple compared to their true stellar capabilities. Furthermore, it would appear that they physically positioned the selected planetoid (Moon) around this planet, in just the right orbit to acquire the proper aquatic extraction to create this biosphere Earth/Dry Land. Moreover, they bodily selected just the right size Moon to perform the converting task based on the size of the aquatic world to be altered. So just how many other planets have these universal beings created (altered/modified)?

Celestial Motive

This world altering premise would seem like a lot of cosmic strife without some type of long range motivation behind such a revolutionary creation. Why endeavor the mass manipulation of an entire world, unless there was some devised cosmic plan involving that planetary modification? Analyzing this extraterrestrial intervention from their possible perspective, it's quite reasonable to assume that they would have never arrived at this raw

world, unless of course they were already exploring the Universe.

However, in the case of our home world, (Earth) it appears they came prepared to modify this pre-existing world before they actually arrived at the Planet to perform the alteration. This conjecture becomes even more credible if we consider that at the time of their arrival they were presently towing or transporting a specifically selected Moon to perform the physical creation of Earth (dry land). This would suggest that they had explored this solar system long before the creation actually took place.

Evidently, they returned at a later time to perform the lunar modification on the most likely planet within this solar system suitable of being aquatically transformed into a biosphere. Moreover, they may have selected and transported a Moon from within the close proximity of this solar system to perform the corporal conversion (Creation). But why?

I soon realized that the solution to this puzzling issue may actually reside within our own history. Mankind, discovering that this Planet is not flat, struggled to expand his dominated territories upon its surface. The history of the United States is a good illustration of such global expansion. Mankind crossing the pond slowly moved further and further into the yet unexplored territorial United States. Pioneering his newly discovered land, mankind began marking the territories with his own kind. Hence, we humans laid claim to those discovered regions by the very populations now residing within them.

The only way to truly prove one's mark or discovered territory would be to leave something behind, or place something on the discovered domain to physically identify, and confirm the discoveries and jurisdiction of the finder. In our case here in America, we ourselves, along with our industrial methods, are the proof of our discovered and dominated territory.

In the case of these cosmic beings, the expansion of universal territories or frontiers could in all probability follow the same procedure, but on a cosmic scale. If these sovereign entities are exploring and marking their territories within the known Universe, they would need to physically lay claim to, or leave something behind to prove or identify the discovered and/or physically created worlds as theirs.

The lunar conversion of this world would not be enough to identify this planet as theirs. Obviously, there could be hundreds of thousands, if not millions of planets, much like this lunar created earth, naturally existing within the Universe. To truly mark their territory within this Constellation and Galaxy they would have to leave behind more than just an artificially converted world.

Unmistakably, mankind was not created for this manufactured biosphere, but rather the biosphere was created for mankind. Evidently, intelligent humanoid life already existed before the lunar transmutation was implemented, thus justifying the motivation behind the creation of a biosphere capable of sustaining human life. Put simply, these world altering entities are also humanoid in nature.

Laying Claim to the Creation

The only way to physically and acceptably expand their universal domain would be to leave behind something that would actually identify the discoverer and/or developer of that territory. To do so, they would have to leave behind, or mark their discovered and artificially created territory with one of their own kind, or a **facsimile thereof**. This colonizing premise may actually justify the cosmic logic behind the procreation of an Adam and Eve.

1:26 And God said, Let us make man in our image, after our likeness: and let them have dominion over the fish of the sea, and over the fowl of the air, and over the cattle, and over all the earth, and over every creeping thing that creepeth upon the earth.

1:27 So God created man in his [own] image, in the image of God created he him; male and female created he them.
1:28 And God blessed them, and God said unto them, Be fruitful, and multiply, and replenish the earth, and subdue it: and have dominion over the fish of the sea, and over the fowl of the air, and over every living thing that moveth upon the earth.
GENESIS

“Let **us** make man in **our** image”. The question is, who is “**us**” and “**our**”? The answer to which appears to be the physical entities resembling us, considering we were created in their “likeness/image”. Clearly, Yahweh (God) was not alone in his endeavors to pioneer and dominate this Universe. The optimum way to mark this planet as a part of their discovered universal domain would be to leave behind a reproduction or facsimile of the discoverers (creators).

This unquestionable mark would ultimately populate the entire planet with facsimiles of the discoverers which we are in the image thereof. Adam and Eve were therefore created as substantial marks to populate the fabricated biosphere.

The Hybridization of Man

Was mankind in fact a created byproduct of these alien beings confessing we were biologically formulated from their own physical nature (image)? The verses would even go so far as to imply that mankind is in the very image of God, (Yahweh), suggesting that Yahweh and his cosmic host are in fact physical men, or facsimiles thereof. However, this speculation would lead us to yet another perplexing issue.

Why create a human in the image of God? If these alien entities came to this world eons ago to create a biosphere, why not simply leave behind their own kind, to populate the transfigured world? Why genetically procreate a human in their image, if celestial humans (“us/our”) already existed? The solution to this complex issue may actually reveal the fact that these celestial beings do not physically procreate.

After a thorough investigation, it became evident that these unique entities are immortal beings not requiring biological reproduction to preserve their species. This celibate detail might resolve the issue as to why create a man and woman. Obviously the converted world is in need of a proliferating population to lay claim to the planet.

Yet, this would suggest that Adam and Eve were not genetic conceptions deriving from just these alien beings alone. The contemporary homo sapiens may actually be a hybrid form of alien genetics combined with an unknown dissimilar gene. The question is, a crossbred species between alien beings and what?

The Missing Link

It’s commonly believed that mankind ultimately evolved from the ape, or Neanderthal man, being nothing less than a highly-developed form of apes. This would suggest that an evolutionary stage of the primate or Neanderthal man may have actually been prevalent on the surface of this planet before and/or after the lunar conversion. Essentially, the ape, or Neanderthal man, was a natural evolutionary life form found on this planet prior to its discovery by these alien explorers.

This would suggest that the ape and its evolutionary stages is an innate occurrence within the Universe and would naturally exist on numerous other worlds. Yet, the crude anthropoid species (apes) possibly found on life-sustaining planets within the Universe would biologically develop towards dissimilar evolutionary levels at various times. Some planets and their basic anthropoid life forms may have evolved millions of years before this planet was formed or even existed.

This might indicate that these celestial entities actually evolved from the same basic life forms as we humans have. In fact it’s quite possible that they are nothing more than an

extremely evolved anthropoid life form found on many planets throughout the Universe. Essentially, the various alien factors found within the Universe may actually be a variety of highly-developed life forms of what we humans are today, evolved anthropoids/apes.

This is not to say that the anthropoid species is the only type of universal life to evolve into an intelligent being. The Grays, and the numerous dissimilar entities frequently observed in many UFO encounters would indicate that there are many types of visiting beings. Quite naturally, hundreds of thousands of dissimilar life forms may be residing within the known Universe.

Nevertheless, the ape may in fact be our ancestors, as well as the forefathers of these planet transforming entities. Moreover, if these celestial beings are a highly evolved form of anthropoid, it would seem rather convenient to simply genetically crossbreed themselves with a lower form of their own existence. In doing so, they could procreate an underdeveloped species that would closely resemble that of their own kind.

As farfetched as it seemed, I began to consider the probability that these stellar entities arrived at this raw aquatic world, only to find the same un-evolved anthropoid life forms already existing upon its surface. That pre-existing life form may have been the Neanderthal man or an evolutionary derivative thereof, the same life forms that these celestial individuals evolved from themselves.

These planetary architects may have genetically hybridized themselves with a lower form of themselves, consequently procreating a highly-developed form of Neanderthal man. In essence, they altered the evolutionary sequence of the Neanderthal, by genetically forcing it into an evolutionary leap.

Put simply, these alien entities may in fact be the genetic missing link between the Neanderthal man and contemporary Homo sapiens. This hybridized humanoid creation would allow the populations of this planet to proliferate within the same genetic lines as the cosmic entities that artificially modified the Planet in the first place. This would biologically mark, and physically lay claim to the transformed world as their own, seeing how the augmented populations of the converted world will be inhabited by their own kind (in the image thereof).

Body Modifiers

Scripture would lead one to believe that this immense cosmic plan for the colonization of a new world was thwarted by a single Tree. Many would rather believe that the famed Trees of life and knowledge was nothing more than a symbolic reference to something other than genuine Trees. Yet, scripture establishes the fact that the Trees did actually exist on the surface of this modified world at one time.

2:9 And out of the ground made the LORD God to grow every tree that is pleasant to the sight, and good for food; the tree of life also in the midst of the garden, and the tree of knowledge of good and evil.

2:16 And the LORD God commanded the man, saying, Of every tree of the garden thou mayest freely eat:

2:17 But of the tree of the knowledge of good and evil, thou shalt not eat of it: for in the day that thou eatest thereof thou shalt surely die.

Each of the fruit bearing trees was not only being cultivated out of the newly established dry land, but actually possessed artificial body enhancing powers. Obviously the trees were authentic, considering their fruit could be bodily consumed. Furthermore, it would appear that Adam and Eve were only alive because they consumed the fruit from the tree of life. Evidently, there's more to this body sustaining fruit than meets the eye.

2... I passed along above the angel Zateel, and arrived at the garden of righteousness. In this garden I beheld, among

other trees, some which were numerous and large, and which flourished there.

3. Their fragrance was agreeable and powerful, and their appearance both varied and elegant. The tree of knowledge also was there, of which if any one eats, he becomes endowed with great wisdom.

4. It was like a species of the tamarind tree, bearing fruit which resembled grapes extremely fine;...

CHAP. XXXI. BOOK OF ENOCH

16 "He further said to me, 'When thou hast taken them to thyself, give them to eat of the fruit of the Tree of Life, and give them to drink of the water of peace; and clothe them in a garment of light, and restored them to their former state of grace....

Seemingly, these extraterrestrials had discovered or developed fruit trees with body-changing or regenerating powers. The body modifying functions found within the fruit can actually be observed in the verses.

Evidently, one of the fruit trees was highly effective in augmenting one's psychological aptitude (Tree of knowledge). This would suggest that the phenomenal fruit contains a powerful nectar of instantaneous genius. Another species (Tree of life) may have allowed cellular rejuvenation of the body.

Note, "restore them to their former state". What was their original biological state prior to eating the fruit? Clearly, the fruit of this life providing Tree had physically altered Adam's and Eve's biological functions in some way.

The same life-giving data can also be found in the verses of Genesis. Here the verses link this same life-sustaining fruit with their death. It would seem that the fruit of the Tree of life is self-explanatory. As long as they eat the fruit of this remarkable Tree they will live. However, if they stop eating the life bearing fruit they will "die".

By eating this miraculous fruit, they have become immortal beings immune to ageing death. Adam and Eve could have physically lived for hundreds, or perhaps thousands of years as long as they continued to consume the fruit of the Tree of life. Yet, there was a mandated stipulation pertaining to the phenomenal fruit (immortality). Those defied conditions ultimately led to the aging downfall of all mankind.

Evidently, these two immortal beings were to become the prototype parents and mentors of this transfigured world. Unfortunately, by dining on the fruit of the Tree of knowledge, Adam and Eve breached Yahweh's cosmic law. Consequently, Adam and Eve, as well their forthcoming posterity, were deprived of the fruit of the Tree of life. 3:4 And the serpent said unto the woman, Ye shall not surely die:

3:5 For God doth know that in the day ye eat thereof, then your eyes shall be opened, and ye shall be as gods, knowing good and evil.

3:6 And when the woman saw that the tree [was] good for food, and that it [was] pleasant to the eyes, and a tree to be desired to make [one] wise, she took of the fruit thereof, and did eat, and gave also unto her husband with her; and he did eat.

3:7 And the eyes of them both were opened, and they knew that they [were] naked; and they sewed fig leaves together, and made themselves aprons.

Regrettably, this was a substantial price to pay for negligible knowledge. Then again, this scholarly fruit may cellularly contain an intellectual powerhouse. Obviously, this mind-altering

fruit was capable of bestowing superior knowledge upon Adam and Eve. Moreover, this genius level possibly reached the intellectual heights of the celestial beings that partook of the same fruits (“Gods”).

3:22 And the LORD God said, Behold, the man is become as one of us, to know good and evil: and now, lest he put forth his hand, and take also of the tree of life, and eat, and live for ever:

GENESIS

Here again the word “us” is used to identify the many physical beings residing within the same earthly settlement Adam and Eve had been forced to leave. Having consumed the fruit of the Tree of knowledge, Adam and Eve had artificially become as intellectually superior as their creators. Apparently this mind-altering event was not to be tolerated by Adam and Eve’s stellar sires. To be as psychologically superior as their celestial creators, as well as possessing the power to live forever (immortality), would intellectually rank Adam and Eve on the same level as their extraterrestrial creators.

The Birth of Fallen Angels

Scripture readily establishes the fact that many of the descendants of Adam and Eve lived to be almost a thousand years of age. This longevity lasted only up and until the time of Noah’s deluge. At that point in time, a new breed began encountering an ageing death. Seemingly, their dwindling immortality may have been directly related to the genetic residue of the fruit of the Tree of life which Adam and Eve consumed for many years.

TESTAMENT OF ADAM (P)

24:5 And I saw, as it were, Adam, and Eve who was with him, and with them the crafty adversary and Cain, who had been led by the adversary to break the law,...

APOCALYPSE OF ABRAHAM (P)

6 “Hear, O my son, hereafter there shall come a great destruction upon this earth on account of them; God will be angry with the world, and will destroy them with water.

7 “But I also know that thy children will not hearken to thee, and that they will go down from this mountain and hold intercourse with the children of Cain, and that they shall perish with them.

31 And when they looked at the daughters of Cain, at their beautiful figures, and at their hands and feet dyed with color, and tattooed in ornaments on their faces, the fire of sin was kindled in them.

Obviously, Cain, Abel, and Seth were not the only posterity of Adam and Eve. Notably, Eve bore one or more daughters that the boys may have lustfully killed over. Evidently the engendered human race derived from an incestuous households, a self seeding union stimulated by Satan and his host (The Adversary),

You will also discover that the impending flood of Noah is notably specified as a result of the daughters of Cain. This significant clue will assist us in comprehending just who Satan and

his universal host may actually be (The Adversary).

Clearly, Cain and Seth fathered many daughters, suggesting that Cain and Seth maintained extremely long life spans to produce the numerous daughters submitted in Scripture. It would seem that from this point on, mankind was faced with short-lived lives spanning only one hundred and twenty years of age. Evidently, Adam and Eve, along with their offspring, maintained their fruitful longevity up until this period of time. This would lead one to assume that Yahweh and his host had removed all of the life-sustaining fruits from mankind's presence. In doing so, the life span of humans was greatly shortened by hundreds of years. In fact, it would appear that this life diminishing event involves an explicit objective.

The Sons of God

If the reader will closely examine the verses, you will discover an unknown third party involved with mankind and their daughters. That unknown third group was the "Sons of God." Clearly the Sons of God were genuine palpable men. It doesn't take a genius to realize that these extraterrestrial entities are not only physical in nature, but in the very image of mankind, thus justifying why the earthly women were charmed into sensual copulation.

It is said that on the second day of the creation (Lunar conversion), an enormous celestial war was conducted in Heaven/The Universe. This rebellion was waged between the different extraterrestrial entities (angels) of the various constellations of this Universe (kingdom of Heaven). It's further believed that the size of the rebel legions of Satan numbered in the millions, while the forces of Yahweh were twice that number. The verses above give us a good perception of the motivation that marshaled those constellations and their inhabitants.

Outwardly, Satan and his host turned against God (Yahweh) in an effort to gain cosmic control, ranking himself and his benefactors above Yahweh's jurisdiction. Additionally, Satan

and his disciples were unwilling to accept Yahweh's decision that mankind was to be placed above, or even ranked on the same level as those of the kingdom of Heaven. This obvious clue hinted to the probability that this stellar war took place within this solar system, if not around the recently converted planet (Earth).

Clearly, Satan maintained substantial control over many inhabited worlds, which ultimately magnified Satan into a powerful adversary capable of instigating a horrendous universal campaign. In close observation of the verses, we discover the actual size of the cosmic forces of Satan at the time of that rebellion.

The verses plainly substantiate the fact that it was a "third of the stars"(constellations) within this Universe (Heaven) that elected to follow the mutinous Satan in his stellar campaign. Essentially, the verses reveal the individual revolting star systems and inhabited constellations of the rebelling contenders. Moreover, this information allows us to identify Satan's constellation of origin.

Satan is paraphrased as the Dragon. Yet, more significantly, we are about to discover that Satan, the Dragon, is directly connected to the Constellation Draco (The Dragon). In essence, the fallen angels were incarcerated within the interior domains of this world (Earth).

Remarkably, the fallen angels were still allowed to "fly in the air continuously above the bottomless." The "bottomless" is not only a forthright reference to "the Underworld domains of this world," but to the great oceans and seas of this planet. Essentially, the exiled angels, imprisoned within (inside) the geothermal bowels of this world, were permitted to utilize their superior craft to travel within the atmosphere of this planet above the bottomless oceans and seas. Moreover, these astonishing verses may actually personify the modern UFO enigma.

The effort to dethrone Yahweh and his Universal jurisdiction was not the only cosmic blunder committed by the rebel angels. The fallen angels were previously distinguished as the Watchers/Sons of God. The word "descended", would persuade one to consider that the virile Watchers were orbiting this planet, or possibly based on/or inside the recently installed Moon. This would be the perfect orbital post if one were keeping a watchful eye on the planet and its populations.

If in fact they were orbiting the planet, they would obviously need a physical craft or space station of some type. This substantial craft or station may have been enormous in size, considering it maintained living quarters, maintenance facilities, and possible space craft landing bays to support "two hundred" "descending" Watchers.

Notably, the two hundred watchers concluded among themselves to descend down to the surface of the planet. This decision was based on the fact that they knew they were not to intervene despite a prohibition to interfere with the population of the converted world. Unmistakably, they were more human than we have been led to believe.

The Fallen Angels Debase the Creation

And they took wives unto themselves, and everyone (respectively) chose one woman for himself, and they began to go in unto them. And they taught them magical medicine, incantations, the cutting of roots, and taught them (about) plants. 7:1

And Azaz'el taught the people (the art of) making swords and knives, and shields, and breastplates; and he showed to their chosen ones bracelets, decorations, (shadowing of the eye) with antimony, ornamentation, the beautifying of the eyelids, all kinds of precious stones, and all coloring tinctures and alchemy. And there were many wicked ones and they committed adultery and erred, and all their conduct became corrupt. 8:1,2, I ENOCH (P)

Because they walked in the stubbornness of their heart the Heavenly Watchers fell; they were caught because they did not keep the commandments of God. And their sons also fell who were tall as cedar trees and whose bodies were like mountains.

The Exhortation

DEAD SEA SCROLLS/THE DAMASCUS RULE (CD)

The sensual angels/Watchers/Sons of God, (Elohim), having left their lofty station (The Moon?) within the skies, began teaching humans about medicine, astrology, astronomy, body cosmetics, as well as weapons of war. Essentially the fallen angels/Sons of God betrayed the kingdom of heaven by teaching their celestial powers and culture to the human race.

The ancient Sumerian tablets corroborate this supposition. The Sumerian chronicles inform us that before the arrival of the shining or fiery Dragon-Serpent (Fallen Angels/Sons of God/Elohim/the shining ones), man did not know how to make beautiful clothes, durable shelters or weapons of war.

The Sumerian annals indicate that these alien teachers were “luminous beings”, glowing entities that navigated through the sky in disc-shape craft of fire, strongly resembling the typical UFO report of today. These radiating individuals began teaching, and impregnating the human female population, and ultimately ruled humanity under the leadership of one individual.

In closely scrutinizing the verses, we unmask the plummeting chieftain angel characteristically referred to as Azaz’el, being just another title for Satan. Azazel was also alluded to as one of the Watchers who fell from heaven, as well as the chief of the Grigori (Watchers). He was a powerful angel boasting, “Why should a Son of Fire bow to a Son of Clay?” The Grigori or Watchers (Sons of God/Elohim) were the original titans, brawny humanoid males in contrast to their humble hybridized counterparts defined as mortal men/humans.

Giants Spawned by the Fallen Angels

The fallen angels began copulating with the female issue of the planet, spawning enormous offspring rivaling even their own mighty stature. Seemingly, the genetic mix ultimately fathered bizarre monstrous misfits. In fact “The Book of Enoch”, as well as diverse scripture, would indicate that the hybridized behemoths were enormous beings of incredible dimensions. Obviously these towering giants created many worldly problems, considering they were now sharing a planet with what they considered to be nothing less than benighted dwarfs (mankind).

... they went in unto the daughters of the people on earth; and lay together with them-with those women-and defiled themselves, and revealed to them every (kind of) sin. As for the women they gave birth to giants to the degree that the whole earth was filled with blood and oppression. ... and those who have died will bring their suit up to the gate of heaven. Their groaning has ascended (into heaven), but they could not get out from before the face of the oppression that is being wrought on earth.

9:7-10 And the women became

pregnant and gave birth to great giants whose heights were three hundred cubits. These (giants) consumed the produce of all the people until the people detested feeding them. So the giants turned against (the people) in order to eat them. And they began to sin against birds, wild beasts, reptiles, and fish....

7:2-5

Then Michael, Surafel, and Gabriel observed carefully from the sky and they saw much blood being shed upon the earth, and all the oppression being wrought upon the earth. And they said to one another, “The earth, (from) her empty (foundation), has brought the cry of their voice unto the gates of heaven. And now, [O] holy ones of heaven, the souls of people are putting their case before you pleading, bring our judgment before the Most High.”

9:1-3

I ENOCH (P)

The fallen angels (Sons of God), and their goliath issue, began to multiply out of control, as they caused monumental disorder on the planet. I began to suspect that the Sons of God were not fully aware of the genetic repercussions produced by their interbreeding with mortal females. Yet, as extremely advanced as they were, it seems highly unlikely that they were unaware of the serious genetic error induced by proliferating with mortals. This might suggest that the Sons of God simply did not care.

The verses leave us with the conclusion that the rebel angels had taken complete control over the surface of the Planet. They began inflicting their brutal administration upon mortal man, as well as allowing their monstrous mutations to tyrannize and persecute the mortal humans to no end. Obviously the behemoths insatiably required enormous quantities of food due to their substantial size. Ultimately, mortal men became slaves not only to the fallen angels

(Sons of God), but their huge offspring as well.

Evidently, the titans proliferated into great numbers that overwhelmed the existing food supply. Even the wildlife appears to have massively suffered in wake of the enormous need for food required by the giant hybrids. The verses would even go so far as to suggest that the ravenous giants began to suffer starvation, thus forcing them into cannibalism of their own slaves (mortal man).

Events on the surface of the Planet became extremely unstable, in light of the rebel angels and their gluttonous mutated seed. Evidently mortal men tried to challenge these superior beings and their dominating cannibalistic administration. Regrettably, the humans stood no chance against such advanced beings and their behemoth brood. Ultimately, the terrorized humans were left with only one alternative, comply or die, a death that placed the demised humans on the Goliath menu.

Periodic Visitation of the Creation

The fallen angels (Watchers) were originally left behind to keep watch, and assist the procreated humans when necessary. Yet, it seemed unmistakable that sooner or later someone would eventually “police the police”. Inevitably, the Watchers would routinely be evaluated, or cosmically checked on by the very stellar confederation that left them behind from the Genesis.

The Watchers had now been “carefully observed”, and scrutinized “from the sky”. Evidently, Michael, Surafel and Gabriel had just arrived at this modified world, possibly indicating a substantial craft now orbiting the planet. From this orbital location, they could effortlessly observe (“observe carefully from the sky”) everything that transpired on the surface of the planet.

Plainly, if Michael, Surafel and Gabriel had been here all along, there would be no need to physically observe. They would be fully aware of the detrimental chain of events from the very beginning of the Sons of God/fallen angels’ original descent to the surface of the planet. Evidently, these observant angelic beings had unexpectedly arrived from some place other than this world.

Obviously, the official eyes in the sky did not like what they found. Mortal man, genetically fathered to be the prototype caretakers and universal marks laying claim to this world, had now become oppressed slaves of their very creators.

The lunar creation had become bastardized and totally out of hand. Clearly, the widespread tyranny justified the oppressed mortal prayers for outside help. Essentially, a resolution to ascertain the fate of everyone on the surface of the Planet, including the rebel angels was now in order. That judgment call is nowhere better illustrated than in “The Book of Enoch”.

2. He was wholly engaged with the holy ones, and with the Watchers in his days.

5. Then the Lord said to me: Enoch, scribe of righteousness, go tell the Watchers of heaven, who have deserted the lofty sky, and their holy everlasting station, who have been polluted with women.

6. And have done as the sons of men do, by taking to themselves wives, and who have been greatly corrupted on the earth;

7. That on the earth they shall never obtain peace and remission of sin. For they shall not rejoice in their offspring; they shall behold the slaughter of their beloved; shall lament for the destruction of their sons... CHAP. XII.

[SECT. III] BOOK OF ENOCH

1. Then Enoch, passing on, said to AZAZEL: Thou shalt not obtain peace. A great sentence is gone forth against thee. He shall bind thee;

3. ...on account of every act of blasphemy, tyranny, and sin which thou hast discovered to the children of men. CHAP. XIII. 1. ...Go say to the Watchers of heaven, who have sent thee to pray for them, You ought to pray for men, and not men for you.

2. Wherefore have you forsaken the lofty and holy heaven, which endures for ever, and have lain with women; have defiled yourselves with the daughters of men; have taken to yourselves wives; have acted like the sons of the earth, and

have begotten an impious offspring?

3. You being spiritual, holy, and possessing a life which is eternal, have polluted yourselves with women; have begotten in carnal blood; have lusted in the blood of men; and have done as those who are flesh and blood do.

4. These however die and perish.

6. But you from the beginning were made spiritual, possessing a life which is eternal, and not subject to death for ever.

7. Therefore I made not wives for you, because, being spiritual, you dwelling is in heaven.

CHAP. XV. BOOK OF ENOCH

Enoch was involved with not only Yahweh and his physical host, but Satan and his mutinous flock (the Watchers) as well. Additionally, the verses reveal where the Watchers/Sons of God, (Satan and his host) were physically residing prior to their actual descent to the surface of the planet. That orbital detail is confirmed by the declaration of an “everlasting station” located in “the lofty sky” (heaven/outer space). Naturally the assertion “everlasting station” may be a direct testimony to the fallen angels’ cosmic rank, or status within the kingdom of heaven.

However, given my analysis, it’s clear we’re dealing with physical entities. Therefore, a more likely interpretation is that the ‘everlasting station’ refers to an orbiting space vehicle (The Moon?).

STATION -. *a depot. An establishment equipped for observation and study.*

The word “station” is directly related to the word “everlasting”. Quite naturally, immortal beings would require a massive immortal, (everlasting) station/craft of operations from which to function. Notably, these stellar entities are not typical humans by our earthly standards.

Yet, the verses do authenticate the fact that these cosmic beings are physically immortal entities that possess a “life” (body). This concrete detail is substantiated by the fact that these celestial individuals performed sexual intercourse with carnal females.

Celestial Assessment and Retribution

Obviously a judgment call had now been ordained upon the immortal angels and their goliath offspring. Yet, the imposed judgment would suggest that two entirely dissimilar castigations are to be inflicted. Unmistakably, the Giants and mankind were to meet with slaughter and destruction. However, the fallen angels themselves (Watchers/Sons of God) were to be bodily bound: “he shall bind thee”.

10:8 And the whole earth has been corrupted by Azazel’s teaching of his (own) actions; and write upon him all sin.

10:9 And to Gabriel the Lord said, “Proceed against the bastards and the reprobates and against the children of adultery; and destroy the children of adultery and expel the children of the Watchers from among the people. And send them against one another (so that) they may be destroyed in the fight, ...

10:12 And when they and all their children have battled with each other, and when they have seen the destruction of their beloved ones, bind them for seventy generations underneath the rocks of the ground until the day of their judgement and of their consummation, until the eternal judgement is concluded.

14:4 ...and judgment is passed upon you.

14:5 From now on you will not be able to ascend into heaven unto all eternity, but you shall remain inside the earth, imprisoned all the days of eternity.

14:6 Before that you will have seen the destruction of your beloved sons ...

10:2 ...for the earth and everything will be destroyed. And the deluge is about to come upon all the earth; and all that is in it will be destroyed,

10:4 And secondly the lord said to Raphael, “Bind Azazel hand and foot (and) throw him into the darkness!” And he made a hole in the desert which was in Duda’el and cast him there;

10:5 he threw on top of him rugged and sharp rocks. And he covered his face in order that he may not see light;

67:1 In those days, the word of God came unto me, and said unto me, “Noah, your lot has come up before me-a lot

without blame, a lot of true love.

67:2 At this time the angels are working with wood (making an ark) and when it is complete, I shall place my hand upon it and protect it and the seed of life shall arise from it; and a substitute (generation) will come so that the earth will not remain empty (without inhabitants).

67:4 And they shall imprison those angels who revealed oppression in that burning valley which my grandfather Enoch had formerly shown me in the West among the mountains of gold, silver, iron, bronze, and tin.

67:5 I also saw that valley in which there took place a great turbulence and the stirring of the waters.

67:6 Now, when all this took place, there was produced from that bronze and fire a smell of sulfur (which) blended with those waters.

67:7 This valley of the perverse angels shall (continue to) burn punitively underneath that ground...

67:8 Those waters shall become in those days a poisonous drug of the body and a punishment of the spirit unto the kings, rulers, and exalted ones, and those who dwell on the earth; lust shall fill their souls so that their bodies shall be punished...

67:9 In proportion to the great degree of the burning of their bodies will be the transmutation of their spirits forever and ever and ever...

67:10 So the judgment shall come upon them, because they believed in the debauchery of their bodies and deny the spirit of the Lord.

I ENOCH (P)

Here again we find “Azazel”, marking Satan as the principal luminary and instigator of the insurgent angels, and their behemoth brood. Unmistakably, two entirely dissimilar events had occurred. The first episode was the psychological maneuver that compelled the giants to violently turn on each other. The second sequel was the imprisonment of the fallen angels within (inside) this planet

The verses do in fact clarify the detailed discipline to be inflicted upon the exiled angels. One of those imposed penalties was the actual loss of their physical right to space-travel, “ascend into heaven,” beyond this planet. This would lead one to believe that a second set of Watchers may have stayed behind to ensure that the defiant Sons of God did not leave this world to inflict their tyrannical methods elsewhere.

Moreover, the fallen angels are to be bound (“bind them”). The genuine location of their bound incarceration can actually be found in the same verses. They are to be bound “underneath the rocks of the ground”, they are to be “imprisoned” “inside the earth”, “into the darkness”, hidden from the light of the Sun. In essences, the mutinous angels were physically confined inside this planet where there are “burning valleys”, and the “smell of Sulfur”.

How could physical living entities possibly survive within the interior geothermal domains (“inside”) of this world? Yet, therein lies the clue, seeing how the verses do not proclaim that the fallen angels are residing inside the magma of the planet, but rather “Burning Valleys”.

The verses actually inform us that the unruly angels have been isolated within the interior domains, or subterranean “valleys” of this world, adjacent to volcanic magma, or Rivers of fire. This ardent underworld technicality actually elaborates upon the words “smell” and “Sulfur”.

The word “smell” would outright suggest an atmosphere in which the odor of sulfur can be sensed. This would indicate a sulfur laden atmosphere located somewhere inside this Planet. That subterranean locality is housing an open space, hollow void, or regional “Valleys” for that Sulfur burdened atmosphere to exist.

In essence, we may be unraveling chronicled evidence of a genuine Underworld domain located inside this planet. This subterranean region may harbor enormous caverns (“Valleys”) reeking with the odor/smell of sulfur, due to the (“Burning”) rivers of volcanic magma running throughout them. These huge caverns could in all probability contain numerous underground springs or rivers of water merging with the magma and sulphurous atmosphere, thus producing a fiery Underworld hell.

This is not to say that the Planet is hollow. Yet, the crust of the Earth is enormously thick, an outer world husk viably honeycombed with colossal caverns that have been geothermically produced. Logically, if land masses, mountainous volcanoes and volcanic upheavals on the surface of the Planet were created by volcanic magma springing up out of the earth's interior, then quite naturally huge hollow voids or caverns would be left behind inside the outer crust of the planet in absence of the now surfaced Magma. Essentially, these hollow voids or caverns could be as large as mountains.

The scriptural implication is that this planet genuinely possesses a concealed, but tangible Underworld domain. Furthermore, this subterranean empire may actually harbor fallen angels boasting technological superiority far beyond our wildest comprehension. Moreover, these highly advanced fallen angels are just waiting for the day that “the eternal judgment is concluded”. This will unleash the rebel angels from their subterranean penitentiary to once again rule humanity.

Noah's Ark

Notably, the verses validate the fact that Noah was directly involved with events working up to the final demise of the surviving giants and mankind. Moreover, there is a systematic sequence that actually provides us with the motivation behind the construction of Noah's Ark.

First, the giants and corrupt mankind were partly exterminated by self-decimation while their stellar forebears (fallen angels) were forced to watch. Second, the fallen angels were not killed, but rather incarcerated inside the subterranean domains of this world. Third, Noah was to build an Ark to escape the deluge designed to destroy the lingering debased populations of the Planet.

Yet, why liquidate the surface of the planet if the giants have largely been destroyed? Why devastate the surface of the planet if the fallen angels have been physically confined to the subterranean realms (inside) of this world? The answer is obvious.

6:5 And God saw that the wickedness of man [was] great in the earth, and [that] every imagination of the thoughts of his heart [was] only evil continually.

6:6 And it repented the LORD that he had made man on the earth, and it grieved him at his heart.

6:12 And God looked upon the earth, and, behold, it was corrupt; for all flesh had corrupted his way upon the earth.

6:13 And God said unto Noah, The end of all flesh is come before me; for the earth is filled with violence through them; and, behold, I will destroy them with the earth.

GENESIS

The enduring demoralized humans, as well as the surviving giants still remained on the surface of the planet. The surviving populations would only need to proliferate, consequently spawning the very same corruption previously established by the fallen angels.

Clearly, Yahweh was prepared to start over with the colonization of the Planet. Noah and his pure lineage morally qualified for the new generation of mankind. Remarkably, the verses genuinely submit that it was Yahweh and his celestial host that constructed the Ark, and not Noah. This is quite believable, if we consider the immense size of the proposed Ark. This massive Ship/Ark actually reveals astonishing dimensions of four hundred feet long, seventy-five feet wide, and forty-five feet high.

If the Ark were being built by Noah, his three sons and their wives, it would have taken them their entire lifetime, along with a forest of cut and formed lumber. Not to mention the tools, levers, pulleys and the substantial manpower required to operate them.

As for the selected animals of the world allowed to survive the inundation, the same rationality may apply. Let's be realistic! It's highly improbable that Noah traveled the entire

world to physically collect and transport every conceivable species of animal to the given location of the Ark.

Noah must have received some type of physical assistance from an unknown source. That global support may have come in the form of Yahweh and his cosmic host utilizing their numerous craft to gather, and physically transport [some] of the regional animals to Noah Ark.

Furthermore, I personally do not believe Noah shepherded two wild and uncontrollable lions, tigers, bears, elephants, or even rhinos, into the Ark. This zoological nightmare obviously required some type of mental manipulation inflicted upon the wild animals. This would suggest that Yahweh and his host were fully capable of mentally exploiting the wild animal psyche into a docile state manageable by humans.

Additionally, it's highly probable that in light of the impending inundation, Yahweh and his host substantially supplied arks, (ships/craft) of their own. This extraordinary speculation would suggest that Yahweh utilized many enormous craft to collect and orbitally store as many animals as they could until the deluge had ended.

It may have taken millions of years after the original lunar conversion (Creation) to substantially evolve the now existing animal population. It would take too long to restart the animal evolution all over again. Therefore, they had to be saved if they were to be replanted to replenish the planet.

3:5 Likewise the watchers departed from nature's order; the Lord pronounced a curse on them at the flood. On their account he ordered that the earth be without dweller or produce.

TESTAMENTS OF THE TWELVE PATRIARCHS (P)

4:10 and the angel said to me, "Rightly you ask me. When God made the flood upon the earth, he drowned every firstling, and he destroyed 104 thousand giants, and the water rose above the highest mountains 20 cubits above the mountains, and the waters entered into the garden, bringing out one shoot from the vine as God withdrew the waters.

4:11 And there was dry land, and Noah went out from the ark 3 BARUCH/SLAVONIC

70:22 ...For the devil became ruler for the third time. The first was before paradise; the second time was in paradise; the third time was after paradise,<and> continuing right up to the Flood. 2 ENOCH [J] (P)

6:13 And God said unto Noah, The end of all flesh is come before me; for the earth is filled with violence through them; and, behold, I will destroy them with the earth.

6:17 And, behold, I, even I, do bring a flood of waters upon the earth, to destroy all flesh, wherein [is] the breath of life, from under heaven; [and] every thing that [is] in the earth shall die.

7:4 For yet seven days, and I will cause it to rain upon the earth forty days and forty nights; and every living substance that I have made will I destroy from off the face of the earth
GENESIS

Yahweh will "destroy them with the Earth". Essentially, Yahweh utilized something that already exists on the planet to destroy the Earth/land. Yet, the word "flood" lacks' substantial detail in describing what was physically implemented in the earthly inundation. Just how did the flood actually occur?

The Flood of Noah

Is it literally possible for unremitting rainfall to totally submerge this entire planet above its own mountain tops? I think not! In fact, I would go so far as to state, it's naturally impossible. I submit that nature itself will assist us in validating the fact that rains alone could not have generated the great flood of Noah.

To better comprehend this earth submerging development we need to analyze how nature generates rain. Water on the surface of the planet is evaporated into the Earth's atmosphere, thus forming enormous rain clouds. The greater the evaporation the more abundant the rainfall. Without water evaporation there would be no rain. Therefore, the question should be, where did the clouds get their substantial evaporated water supply to create rain? Obviously,

“evaporation” holds the key to the forty day and night inundation of Noah.

However, there is a major difference between rain and the deluge of Noah. Rain does not occur where there is no water to begin with. Clouds do not produce water vapor or rain on their own. If they did, this entire planet would be completely submerged underwater today.

It’s the enormous oceans, seas, lakes and rivers of this world that feed the clouds. If there were no oceans, seas, rivers, or lakes there would be no rain. If it continuously rained for forty days and nights, all that would physically occur is the constant recycling of preexisting water reservoirs on the surface of the planet. There would be no surplus of water added to the already existing water supplies that are either located on the surface of the planet, or in the atmosphere.

Eventually, the overwhelming inundation would run back to the oceans, seas, lakes and rivers of the planet from whence they came. In doing so, the waters would once again be evaporated into the atmosphere, accordingly generating rain all over again. Simply put, water seeks its own level.

This is not to say there would be no massive flooding induced by the tremendous deluge. Yet, the inundating rains would only establish burdensome volumes of water storming the land masses of the planet in a furious torrent to seek out and find the oceans, seas, lakes, and rivers of the world. (its own level/water table)

Naturally, the massive moving torrents of water would literally cut new earthly ravines, gorges, and rivers into the huge land masses. Nevertheless, the inundating waters would **not** cover the continental land masses of this planet above its mountain tops.

Obviously, the water table of the planet establishes a discrepancy in the inundation of Noah. Yet, the solution to this perplexing issue has already been resolved by not only the verses above, but also earlier in the chapter of Genesis. In closely scrutinizing Noah’s chronicles, we discover that more than just a global inundation was used to destroy the surface of the Planet.

7:11 In the six hundredth year of Noah's life, in the second month, the seventeenth day of the month, the same day were all the fountains of the great deep broken up, and the windows of heaven were opened.

7:12 And the rain was upon the earth forty days and forty nights.

GENESIS

We now have an additional incident that was used to perform the aquatic destruction of the planet. The verses even give us the sequence in which each episode transpired. In fact, it was the first primary aquatic event that produced the repercussions of the second.

Clearly, the inundating rains did not develop until **after** “all the fountains of the great deep were broken up”. This was precisely “the same time ” when the windows of heaven (sky) opened up generating forty days and nights of rain.

Reverse Lunar Conversion

Plainly, “the fountains of the great deep” identify all the great oceans, seas, lakes and rivers of this planet. These great deeps actually dominate the underground rivers, springs and/or fountains of the world. Yet, how does one literally break up all the great oceans, seas, lakes and rivers (Deeps) of an entire planet to constitute rain? Surprisingly, we have already analyzed, and systematically organized the prevailing aquatic events.

The verses are actually informing us that a reverse Lunar Conversion had occurred. Therefore if we examine the lunar conversion of the planet in reverse, we simultaneously satisfy the inquiry as to how the aquatic inundation of Noah came about.

Before the lunar transmutation occurred, the planet consisted of negligible land masses

and enormous swamps and marshlands. Naturally, with most of the surface being submerged underwater, the atmosphere of the planet at that time was entirely different from today's sun-permeated world. By more water occupying the surface of the planet, more consistent aquatic evaporation would logically take place within the atmosphere, consequently spawning horrendous storms and rainfall on a global scale.

By establishing a Moon around the aquatic world, all the waters on the surface of the planet would be "gathered together" due to the gravitational pull of the newly installed Moon. Hence the global aquatic reservoirs (Oceans/Seas) of the planet would be pulled away from the negligible land bodies, thus exposing the submerged land masses.

Consequently, the surface of the planet would now possess more land mass with considerably less water mass, which in turn physically transfigured the atmosphere of the planet. The once rainy and heavy overcast skies of the world now became constrained, due to the decreased aquatic territories exposed to the heat of the Sun.

In essence, to bring about the flood of Noah, the kingdom of heaven extracted the Lunar Satellite (Moon) from around the planet. Simply put, they reverted the planet back to its original aquatically engulfed condition which constantly generates rain.

9. ... Go for I have ask the Lord of spirits respecting this perturbation of the earth; who replied, On account of their impiety have their innumerable judgments been consummated before me. Respecting the moon have they inquired, and they have known that the earth will perish with those who dwell upon it, and that to these there will be no place of refuge for ever.

CHAP. LXIV. [SECT. XI.]

1. After this he showed me the angels of punishment, who were prepared to come, and to open all the mighty waters under the earth:

2. That they may be for judgment, and for the destruction of all those who remain and dwell upon the earth. CHAP. LXV. THE BOOK OF ENOCH

He threw clouds together and hid the brightly gleaming disk. Having covered the moon, together with the stars, and the crown of heaven all around, he thundered loudly, a terror to mortals, sending out hurricanes. All the storm winds were gathered together and all the springs of waters were released as the great cataracts were opened from heaven, and from the recesses of the earth and the endless abyss measureless waters appeared and the entire immense earth was covered. THE SIBYLLINE ORACLES Book 1 217-224

Those still remaining on the surface of the planet, including the prevailing giants, were well aware of the fact that the Moon would play a major role in their conclusive demise. This was the very justification behind their respective inquiry about the Moon.

Essentially, these celestial entities were once again "prepared" to employ their matter maneuvering devices to remove the gleaming disk shaped Moon out of its orbit from around the planet. The Moon was hidden from everyone on the surface of the planet due to the cloud engulfing state it globally created.

Moreover, the Moon was physically removed from its existing orbit to be isolated further out into outer space (heaven). This lunar withdrawal ultimately gave the extracted Moon the physical appearance of just another star. In doing so, the **inner** and **outer** waters of the world were physically released to submerge the continental land masses on the surface of the planet.

Accordingly, the atmosphere of the planet was thrown into massive global upheavals. Water vapor would now fill the atmosphere of the planet generating horrendous rainfall, storms, and hurricanes on a worldwide scale. The overcast conditions would create utter darkness upon the surface of the planet. The oceans and seas of the world would now seek a new water level/table, (measure), thus engulfing the entire planet with water.

...the great loud thundering God will reduce the depths of the sea to other measures, having defined it around the land with harbors and rough shores. SIBYLLINE ORACLES Book 1 321-333

34:3 And that is why I shall bring down the flood onto the earth, and I shall destroy everything, and the earth itself will collapse in great darkness. 2 ENOCH [J] (P)

54:7 And in those days, the punishment of the Lord of the Spirits shall be carried out, and they shall open all the storerooms of water in the heavens above, in addition to the fountains of water which are on earth.

54:8 And all the waters shall be united with (all) other waters. ... 1 ENOCH (P)

Global Repercussions

In light of the obscured data concealed within, it's essential that we scrutinize additional verses pertaining to Noah's lunar recall. The removal of the Moon from its orbit around this planet would produce considerably more submerging damage than just horrendous rains, storms, or hurricanes. Obviously the former verses are lacking consequential details in deciphering the full repercussions of such a tremendous lunar event.

70:7 All the earth will change its order, and every fruit and every herb will change their time, for they will anticipate the time of destruction. And all the nations will change on the earth, and all my desire.

70:8 And then I, I shall command the bottomless. It will come out and rush out over the earth, and the storages of the waters of heaven will rush <from above> onto the earth in a great substance in accordance with the first substance.

70:9 And the whole constitution of the earth will perish, and all the earth will quake,... 2 ENOCH [A] (P)

1. In those days Noah saw that the earth became inclined, and that destruction approached.

3. And Noah cried with a bitter voice, Hear me; hear me; hear me: three times. And he said, Tell me what is transacting upon earth; for the earth labours, and is violently shaken.

6. A commandment has gone forth from the Lord against those who dwell on the earth, that they may be destroyed; for they know every secret of the angels, every oppressive and secret power of the devils,... CHAP. LXIV. [SECT. XI.] BOOK OF ENOCH

67:11 And these waters will undergo change in those days; for (on the one hand) when those angels are being punished by these waters, the temperatures of those fountains of water will be altered (and become hot), but (on the other hand) when the angels get out, those waters of the fountains shall be transformed and become cold. 1 ENOCH (P)

Outwardly, the verses sum up the undeniable repercussions of an event that had not yet been revealed. Notably, the entire planet had radically experienced a horrifying aquatic transformation. Moreover, this submerging punishment appears to have literally altered time itself.

The planets' previous days, weeks, months, and years "order" no longer exist. All vegetation in wake of the lunar recall had their normal growing seasons altered. The lunar established continents on the surface of the planet were physically transfigured or rearranged. The entire "constitution" of the planet appears to have been physically reorganized.

Seemingly, the entire planet had been literally moved or turned in some way by the violent cascading waters. In fact, the planet appears to have actually performed a pole shift in Noah's obvious presence. Noah genuinely observed the dawning of the "incline" (pole shift) of the planet as it unbridled death and destruction upon all its remaining surface dwellers.

Inclined - to deviate from the horizontal or vertical; slant. To lower or bend the head or body, as in a nod or bow. To cause to lean, slant, or slope.

It's no wonder "all the nations on earth" (land masses/continents) were transfigured or globally reestablished. It's no marvel that the entire "constitution" of the planet has been physically altered.

Constitution - the basic law of an organized body, physical composition or structure, makeup, construction, design, formation.

It's not surprising that the planet began to labor and violently shake. That which was previously above water before the lunar withdraw appears to have been repositioned and submerged below the oceans and seas of this world today. The continental re-configuration and/or relocation, was due to the planet being tipped or shifted from its normal axes.

As to just how much of a shift the planet may have executed is unclear. What is known to us today as the polar ice caps could conceivably be the true location of the dry continental land masses of this planet prior to the lunar extraction and inundation of Noah.

What used to be the frigid ice caps of the world would now be shifted to warmer locations on the surface of the planet. The warmer oceans and seas of the previous world would now be shifted to colder location, reasonably forming new ice caps as the old ones melted.

This displacing factor may actually resolve the last set of verses, specifying that the incarcerated angels will be allowed out of their subterranean brig after the global shift had concluded. This would indicate that the global waters were entirely dissimilar on the surface and interior of the planet than when the insurgent angels were first imprisoned.

Atlantis Connection

In thoroughly analyzing these Earth altering developments, I was forced into an interesting probability. There may be a link between Noah's lunar deluge and the noted legend of the lost continent of Atlantis/Mu. This myth coincides with all the Earth transforming events examined up to this point.

It is said that at the dawning of time a super civilization existed on the surface of this planet. This highly advanced culture employed the use of various crystals to produce imposing power sources, and technological advances. This super race of beings was alleged to possess incredible flying machines, weapons and devices far beyond the intellectual scope of modern technology today.

The very birth of this super race, as well as its final demise, would fit quite convincingly into the chapters of Genesis. The Atlantean race was alleged to have originated from the stars. Their super civilization ultimately inflicted tyrannizing control over the surface of the planet, as they interbreed, and enslaved its inhabitants.

The Atlantean people alleged that they were foretold of an impending aquatic cataclysm that would destroy the world they dominated. They knew the predicted earthly catastrophe would cause massive earthquakes, geothermal upheavals, and tidal waves before the coming of a new ice age, fattered by the gradual shifting of the poles of this planet.

The Atlanteans were well aware of their impending global cataclysm before it occurred, as did the mutinous angels and their titan descendants. This would lead one to believe that the fallen angels may in fact have been the Atlanteans who established their rebellious regime on the surface of the planet prior to the lunar inundation/pole shift of Noah.

It has been submitted that this technologically superior race flourished on a continent that ultimately sank into the sea. Yet, if the Atlanteans were in fact the fallen angels, their precious continent did not sink into the oceans, but rather the oceans of the world swallowed them alive via the lunar extraction of Noah.

The continent of Atlantis may in reality be what we now distinguish as the North or South

Pole. Then again, the continent of Atlantis could in all probability be in any number of various global locations under the concealing oceans of the Atlantic or Pacific.

Naturally, the aquatic location would depend on the degree or type of pole shift, as well as the newly established location of the reinstalled Moon in contrast to the shift. Essentially, the new lunar orientation would establish land masses where there were none before, as well as submerge old land masses that previously existed.

Lunar Reinstatement

8:1 And God remembered Noah, and every living thing, and all the cattle that [was] with him in the ark: and God made a wind to pass over the earth, and the waters asswaged;

8:2 The fountains also of the deep and the windows of heaven were stopped, and the rain from heaven was restrained;

8:5 And the waters decreased continually until the tenth month: in the tenth [month], on the first [day] of the month, were the tops of the mountains seen.

8:3 And the waters returned from off the earth continually: and after the end of the hundred and fifty days the waters were abated.

GENESIS

The end of the lunar destruction signifies the beginning of the lunar reinstatement. The waters were “asswaged” (asswage - subsided/decreased), insinuating that the waters deviated erratically from their course. Clearly, an outside influence was utilized to manipulate the waters. That outside influence caused, or “made a wind to pass over the Earth” and “stop” all the fountains of the deep.

The verses actually give us the systematic order of events. That orderly procedure began by withdrawing (“asswaged”/gather together) the oceans and seas (fountains of the deep) from around the planet, followed by the “windows of heaven” or “rain from heaven” being “restrained”.

By installing the Moon around the planet for a second time, the lunar metamorphosis would occur a second time. The atmosphere (wind) of the planet would now forcibly be “made” to change, as would be the entire face of the planet.

The atmosphere of the planet would now become aquatically starved due to the extraction of the oceans and seas away from the submerged land masses, consequently forcing the atmosphere into horrendous convulsions. Moreover, the forced displacement of the massive bodies of water on the planet surface would actually create winds as the planet was being converted.

Considering the enormous convulsions the planet may have endured when faced with a possible pole shift, the moon manipulated waters would have taken ample time to fully reestablish themselves around the surface of the planet. This obvious detail is validated by the wording “the waters decreased continually”, “the waters returned from off the earth continually”, “the waters were abated”.

This receding factor would indicate one of two possibilities: Either, the massive bodies of water on the surface of the planet were slowly withdrawn from the submerged land masses as the Moon was gradually inaugurated into its present orbit. Or the Moon was rapidly affixed into its permanent orbit, where it required considerable time to extract the global bodies of water away from the submerged land masses. Either way, there may have been survivors.

Survivors Populate a New World

It’s important to remember that the planet was not entirely an aquatic world before the primary lunar transfiguration occurred. As mentioned before, the planet may have harbored inferior land masses and enormous marshlands. Those negligible land bodies may have been

protruding mountain ranges, or earthly plateaus jutting up out of the submerged planet.

If in fact the lunar constrained oceans and seas were physically released, it would stand to reason that many protruding land masses were not totally affected to the point of killing off all the prevailing inhabitancy.

This speculation would propose that many dissimilar roots of mankind could have survived the second lunar metamorphosis. Those weathering roots could have proliferated into entire nations, possibly accounting for the many diverse empires that appear to have originated from out of nowhere.

If the grand plan was for the lunar induced flood to totally eradicate the evil spawned by the insurgent angels, it would appear that the lunar objective had failed. If in fact, there were survivors other than Noah and his family, they would have undoubtedly been the residues of the giants or debased mankind. This would imply that the evil of the fallen angels still genetically exists.

Obviously the surviving few branched out and began new earthly empires of their own. Furthermore it's significant to remember that the fallen angels were periodically released from their subterranean prison **after** the lunar inundation of Noah was concluded. Moreover, we are about to discover that their covert activity on the surface of the planet will ultimately unravel the mystic gods of Egypt and Babylon.

The Destruction of Sodom and Gomorrah

Sodom and Gomorrah also appear to be a perverted remnant of Noah's lunar inundation. Notably, these demoralized populations seem to have been contaminated by the behavioral characteristics of their fallen angels' ancestry. Evil begets evil, which may elaborate upon the ill will festered within the city walls of Sodom and Gomorrah.

18:1 And the LORD appeared unto him in the plains of Mamre: and he sat in the tent door in the heat of the day;
18:2 And he lift up his eyes and looked, and, lo, three men stood by him: and when he saw [them], he ran to meet them from the tent door, and bowed himself toward the ground,
18:4 Let a little water, I pray you, be fetched, and wash your feet, and rest yourselves under the tree:
18:6 And Abraham hastened into the tent unto Sarah, and said, Make ready quickly three measures of fine meal, knead [it], and make cakes upon the hearth.
18:7 And Abraham ran unto the herd, and fetched a calf tender and good, and gave [it] unto a young man; and he hasted to dress it.
18:8 And he took butter, and milk, and the calf which he had dressed, and set [it] before them; and he stood by them under the tree, and they did eat.
GENESIS

For the first time in our scriptural analysis, it would appear that Yahweh (the Lord) and his stellar disciples have now made their physical presence known. As we shall discover, Yahweh is known to incessantly employ his superior host to interact with humans on the surface of the planet.

Here again, it becomes clear that Yahweh and his universal host possess physical bodies that consume food, and require personal hygiene (wash their feet). The same palpable evidence found within the city walls of Sodom and Gomorrah.

19:1 And there came two angels to Sodom at even; and Lot sat in the gate of Sodom: and Lot seeing [them] rose up to meet them; and he bowed himself with his face toward the ground;
19:2 And he said, Behold now, my lords, turn in, I pray you, into your servant's house, and tarry all night, and wash your feet, and ye shall rise up early, and go on your ways. And they said, Nay; but we will abide in the street all night.
19:3 And he pressed upon them greatly; and they turned in unto him, and entered into his house; and he made them a feast, and did bake unleavened bread, and they did eat.

19:4 But before they lay down, the men of the city, [even] the men of Sodom, compassed the house round, both old and young, all the people from every quarter:

19:5 And they called unto Lot, and said unto him, Where [are] the men which came in to thee this night? bring them out unto us, that we may know them.

19:6 And Lot went out at the door unto them, and shut the door after him,

19:7 And said, I pray you, brethren, do not so wickedly.

19:8 Behold now, I have two daughters which have not known man; let me, I pray you, bring them out unto you, and do ye to them as [is] good in your eyes: only unto these men do nothing; for therefore came they under the shadow of my roof.

19:9 And they said, Stand back. And they said [again], This one [fellow] came in to sojourn, and he will needs be a judge: now will we deal worse with thee, than with them. And they pressed sore upon the man, [even] Lot, and came near to break the door.

19:10 But the men put forth their hand, and pulled Lot into the house to them, and shut to the door.

19:11 And they smote the men that [were] at the door of the house with blindness, both small and great: so that they wearied themselves to find the door.

GENESIS

Clearly the “two angels” were physical “men”. This corporal detail is substantiated by the fact that Lot, and the entire city physically observed them. Additionally, they consumed food, and could have their feet washed. Moreover, If it had not been for the two angels (men), Lot’s door would not have detained such an aggressive mob, which brings us to the how of the matter.

Just how did the two men/angels genuinely stop the assaulting crowd? Obviously, the two men/angels smote the crowd outside the door with blindness. Yet, the word “smote” would suggest a blunt contradiction in reference to the two angels/men.

SMOTE - *To inflict a heavy blow on, with or as if with the hand, a tool, or a weapon. To drive or strike (a weapon, for example) To deal a blow with or as if with the hand or a hand-held weapon.*

The verses would suggest that the two men/angels utilized a weapon, and possibly a hand-held weapon, to assault the crowd. However, when closely scrutinizing the verses we discover that the two angels/men pulled Lot back into the house, at which point they shut the door with everyone inside the house, including the two angels/men. From this concealed location the two men then smote the mob.

How could the two men/angels strike any crowd with a hand-held weapon, or any weapon for that matter, if they were concealed inside the house? The verses would sway one to assume that the two men/angels were not alone in their city calling. Not only did the two men appear to be receiving assistance from another location, but the unknown location looms to be outside the door of Lot’s home.

Tower of Babel and Sodom and Gomorrah Link

Given the violent nature of the cities and their unruly populations, it’s highly unlikely that the two men entered the cities completely alone and unsupervised. This would propose that the two men/angels were under constant surveillance.

Then again, the device itself may shed some feasible light on the blinding blow inflicted upon the crowd. The verses would imply that the crowd was struck with blindness. However, the word blindness harbors numerous meanings, most of which do not imply the lack of visual sight.

BLINDNESS - *Unable or unwilling to perceive or understand. Drunk. Independent of human control.*

Difficult to comprehend.

This detail should sound quite familiar considering the definition is a befitting interpretation of what may have been inflicted upon the builders of the Tower of Babel. This entire population was suddenly struck (smote) with stupidity to the point of babbling at each other.

11:7 Go to, let us go down, and there confound their language, that they may not understand one another's speech.
GENESIS

Ancient mankind being extremely captivated by these physical godlike beings (“us”), began constructing a heaven-bound edifice to reach the stars. Yet, the essential factor to be questioned would be, just how was the verbal confounding of the language of possibly thousands of people performed simultaneously?

CONFOUND - *To cause to become confused or perplexed. To fail to distinguish; mix up. To frustrate.*

It would seem that Yahweh and his host had mentally tampered with, or crippled the speech patterns of everyone involved in the construction of the Tower. We are even informed as to the manner in which the speech patterns were vocally impaired. This obvious clue derives from the word babel, hence the Tower of Babel.

BABEL - *A confusion of sounds or voices. A scene of noise and confusion. Clamor, pandemonium, tumult, commotion of a great crowd. Agitation of the mind or emotions.*

BABBLE - *To utter a meaningless confusion of words or sounds. To talk foolishly To make a continuous low, murmuring sound, To utter rapidly and indistinctly. To blurt out impulsively; Inarticulate or meaningless talk or sounds.*

As we continue to move through Scripture, we will consistently encounter the remarkable ability of Yahweh and his host to manipulate the mind not only of humans, but the animal kingdom as well. The same type of psychological manipulation frequently reported within the modern UFO phenomena.

The mental disruption appears to have caused the workers of the Tower to verbally babble, or speak gibberish resulting in utterance chaos. Essentially, it would seem that some type of mass psychological intervention was inflicted upon the entire population.

Moreover, it would seem that the vocal disruption points an accusing finger at the brain as the culprit. The brain’s main source of behavior patterns derives from electrical impulses that trigger the operation of most all functions of the body including speech.

This might suggest that the babbling incident at the Tower of Babel could have feasibly been executed by an unobserved electro-magnetic field (EMF), pulsed microwave irradiation, or some unknown disrupting fields of energy originating from a concealed craft hovering in the sky. (“let us go down”) These types of unseen energy fields would induce a cerebral breakdown, as the disrupting energy mentally twisted many body functions of the brain, including vision and speech patterns.

Undoubtably, a mental disruption of this magnitude would induce a crowd of any size to

disperse and scatter in as many directions as possible. Essentially, the psychological manipulation at the Tower of Babel and at Lot's home are possibly one and the same. This would suggest that the blinding incident at Lot's home may not have entailed eyesight alone, but a psychological blindness as well.

Furthermore, the blinding episode may have been executed by the two angels while inside Lot's home. Both men may have actually possessed hand-held devices capable of mentally disrupting (blinding) the crowd outside Lot's home while they remained inside.

However, I'm more inclined to believe that both men did in fact come prepared to be confronted by the debased inhabitants of both cities. This would argue that the two men/angels were possibly under constant surveillance by a concealed craft.

That hidden craft and its watchful eyes were possibly prepared to impose death upon anyone who endeavored to harm the two angels. In fact, this observant lofty party may have been the very method of transportation utilized by the two angels to arrive at Sodom and Gomorrah in the first place.

As with the three men who escorted Lord Yahweh ("him"?) to the camp of Abraham, the two men/angels at Sodom and Gomorrah must have procured some type of tangible transportation other than just walking to the city sites from out of nowhere. Essentially, the two men at Lot's home may have been physically transported near the site of Sodom and Gomorrah by the same craft that had a hand in the psychological blindness at Lot's home.

This might imply that a concealed craft could have flooded the area outside Lot's home with some type of unknown energy fields, consequently they caused everyone within the wave induced area to become mentally crippled and/or blind, hence *"they wearied themselves to find the door"*.

19:12 And the men said unto Lot, Hast thou here any besides? son in law, and thy sons, and thy daughters, and whatsoever thou hast in the city, bring [them] out of this place:

19:13 For we will destroy this place, because the cry of them is waxen great before the face of the LORD; and the LORD hath sent us to destroy it.

19:15 And when the morning arose, then the angels hastened Lot, saying, Arise, take thy wife, and thy two daughters, which are here; lest thou be consumed in the iniquity of the city.

19:16 And while he lingered, the men laid hold upon his hand, and upon the hand of his wife, and upon the hand of his two daughters; the LORD being merciful unto him: and they brought him forth, and set him without the city.

19:17 And it came to pass, when they had brought them forth abroad, that he said, Escape for thy life; look not behind thee, neither stay thou in all the plain; escape to the mountain, lest thou be consumed.
GENESIS

Examining the Delivered Weapon

There are some interesting particulars seated within these verses. The verses would not only suggest a specific time frame, but a determined safe distance from the cities as well. Evidently, the two angels/men, possibly fearing for their own lives, do not want to be caught in the immediate area at the time of the destruction.

One might conclude that someone/something was coming to inflict mass destruction. Evidently, the inbound destruction was to arrive at the location of the condemned cities at a given time, possibly justifying why the two men took matters into their own hands.

Note verse 19:16 Lot and his family were "lingering". Obviously, this punctual detail forced the two men/angels to waste no time in physically removing the family. The verses actually go so far as to suggest that the two men had literally and physically taken the hands of the entire family, and pulled them out of the house.

Not only did the two men forcibly remove the family from their own home, they escorted

them outside the city. In fact, the verses would lead one to believe that these two men did much more than just walked Lot's family outside the city walls. This revealing factor is disclosed in the declaration: "brought them forth", "set", and "abroad".

SET - *To put in a specified place. To move toward the shore. To disappear below the horizon. To elevate; raise. To land (an aircraft).*

ABROAD - *Out of one's own country. In a foreign country or countries. Away from one's home covering a large area; widely.*

These definitions literally assist us in resolving the statement "brought them forth". This removed location would propose a distance of many miles. The verses and their defined words would entice one to consider the probability that the two angels brought Lot and his family outside of the city to an awaiting craft.

This anticipated conveyance was utilized to "set" (transport) the entire family "abroad" at a safe distance. Obviously, rapid transportation (craft), would be required if the family and the angels were to quickly establish a vast distance between the cities and themselves. This possibly justified the two angels hasty time frame and expeditious removal of Lot's family from the city.

Just how many miles would be considered a safe distance? In close observation of the verses, it would seem that Lot's family was only transported to the outer fringes of what might be considered a kill zone. Yet, Lot and his family were still not out of danger until they entered into the mountains.

This might suggest that Lot and his family were literally transported directly to the edge of the mountain range for that very reason. This would allow Lot and his Family to shield themselves within the mountains to escape the repercussions of the weapon. Obviously, the weapon in question required an extensive distance if one wishes to abide within a safe zone. In fact, the powerful device actually appears to resemble one of the assorted nuclear devices mankind possesses today.

19:24 Then the LORD rained upon Sodom and upon Gomorrah brimstone and fire from the LORD out of heaven;

19:25 And he overthrew those cities, and all the plain, and all the inhabitants of the cities, and that which grew upon the ground.

19:26 But his wife looked back from behind him, and she became a pillar of salt.

19:27 And Abraham gat up early in the morning to the place where he stood before the LORD:

19:28 And he looked toward Sodom and Gomorrah, and toward all the land of the plain, and beheld, and, lo, the smoke of the country went up as the smoke of a furnace. GENESIS

2:6 And turning the cities of Sodom and Gomorrah into ashes condemned [them] with an overthrow, making [them] an ensample unto those that after should live ungodly; II PETER

29:23 [And that] the whole land thereof [is] brimstone, and salt, [and] burning, [that] it is not sown, nor beareth, nor any grass groweth therein, like the overthrow of Sodom, and Gomorrah,... DEUTERONOMY

Obviously, the weapon originated from out of the sky (heaven/outer space). The weapon harnessed enough destructive power to burn up not only the two cities, but the surrounding region as well. At first glance, one might envision a massive super laser weapon was implemented to generate the enormous destruction in just a matter of moments. This possible star wars technology would be consistent with the location from whence the fire (laser) in the sky derived.

However, the weapon in question may not have been the utilization of laser technology, but

rather an unknown nuclear device. This speculation becomes even more credible when we take into account the geographical repercussions defined within the verses.

The verses actually suggest that a nuclear blast may have been employed to hurl smoke and ash soaring up into the atmosphere “as the smoke of a furnace”. The word “furnace” would imply an extensive column of smoke created by the destruction, the same repercussion fathered by a nuclear detonation.

The immense power of the weapon left the countryside a burned up wasteland unfit to cultivate any plant life for many years. The nuclear blast was so powerful Lot and his family had to flee for many miles to escape the horrendous repercussions. Once again, this justified the angels’ vital task to rapidly transport Lot and his family to the mountains to shield them from the blast, blinding light, and horrendous heat.

Flesh to Salt

Remarkably, the verses submit that the weapon transformed Lot’s wife into a pillar of salt. This incredible chronicle would beg the question as to the true nature of the weapon. A query based on, which came first, the chicken or the egg?

The Dead Sea is believed to be the true location of what was once Sodom and Gomorrah. The entire area of the Dead Sea consists of huge rock salt, salt pits, mines, and saline deposits. The Dead Sea is so saline saturated, that a swimmer becomes totally buoyant in its waters. This salt permeated site is so acidic that the atmosphere above the Dead Sea actually diverts birds away from crossing over it.

The question is, was this colossal salt shaker the previous home of Sodom and Gomorrah, before the destruction of the cities, or after? Is it possible the device employed to destroy Sodom and Gomorrah chemically and/or anatomically transformed all living and non living objects within the inflicted area into salt, including Lot’s wife ?

2:9 Therefore [as] I live, saith the LORD of hosts, the God of Israel, Surely Moab shall be as Sodom, and the children of Ammon as Gomorrah, [even] the breeding of nettles, and saltpits, and a perpetual desolation: ... ZEPHANIAH

The word “breeding” would suggest that the weapon physically transformed the entire area into salt. Yet, therein lies another probability. It would seem quite conceivable that the salt pits, and mines within the area of the Dead Sea already existed below the surface of the planet before the destruction of Sodom and Gomorrah actually occurred. If an atomic device was used it would have literally blown up the salt pits hurling enormous salt residue high in the sky as well as all over the entire area, consequently “breeding” “saltpits”.

This speculation would suggest that the weapon used to destroy Sodom and Gomorrah could have explosively actuated the salt mines within the underground area. The salt deposits may have become radically air born while destroying Sodom and Gomorrah, thus bodily inflicting Lot’s wife with heated saline residues while she lingered behind the others to watch.
